

# AUSTRALASIAN LIVING HISTORY FEDERATION

## ALHF MEMBERSHIP RESPONSIBILITIES 2019

All member groups and individual members are responsible for:

- 1. Abiding by the Constitution of the ALHF, the ALHF Safety and Authenticity Principles, and this Member Responsibilities statement (available on the ALHF website)
- 2. Paying membership fees on having their membership approved, and by the date due each year thereafter
- 3. Having adequate group rules and regulations covering health and safety, finance and administration
- 4. Maintaining proper membership records, and supplying membership lists to the ALHF annually or on request
- 5. Keeping a form of member register which contains the full name, contact address and date of joining/renewing for all members including any details required by law regarding weapons/weapon storage by the group or its members
- 6. Being aware of Prohibited Persons legislation in relation to re-enactment activities and/or weapons use in their state, taking reasonable steps to determine if members are subject to prohibition orders and managing any such memberships accordingly. Groups must advise the ALHF of such memberships, especially where a weapon exemption is provided under ALHF auspices/name e.g. Victoria
- 7. Being non-sectarian and non-political, and abiding by laws regarding racism, harassment, bullying and other forms of discrimination
- 8. Not wilfully acting in any way that might result in bringing the ALHF or the practice of historical re-enactment into disrepute
- 9. Obeying the laws of the land and providing information as necessary to enable ALHF to meet its legislative obligations (see following page for legislative links pertinent to your state, and states you may visit for re-enactment activities)
- 10. Dealing with and interacting with other re-enactors, clients and the general public in an ethical, professional and courteous manner
- 11. Portraying their chosen period/s as authentically as is reasonably possible
- 12. Informing the ALHF as soon as practicable of changes to contact details, or any other circumstances that may affect the ALHF
- 13. Notifying the ALHF committee of any proposed activities, events and meetings which may fall outside the terms of the Approved Activities Schedule (available on the ALHF website)

### **OTHER MATTERS**

#### ABOUT INDIVIDUAL MEMBERSHIP

Under the ALHF Constitution, individual membership (membership not associated with being a member of a group) may be considered as a short-term solution for financial members who, through no fault of their own, find themselves without a group. It is granted at the discretion of the ALHF Committee (i.e. it must be requested and reasons provided, it is not automatic). Please contact the ALHF for further information if necessary.

#### ABOUT INFORMATION PRIVACY

ALHF uses personal information obtained during the renewal process:

- to supply membership information, such as membership cards and policy documents, to groups for distribution to members
- to generate reports on member demographics, where individual information is de-identified;
- to communicate with members as part of the ordinary business of the Federation;

The ALHF will not reveal personal details about members to third parties (including other ALHF members) without permission, except in cases where disclosure may be required by law, for example: where there are reasonable grounds to assume a serious offence has been committed; or in the case of a less serious offence when, on balance, the interests of the ALHF and its members would be served by providing the information.
